SUBJECT: Delegation of Authority for Pay Plan for Army Civilian Physicians and Dentists Covered by the General Schedule

1. Reference memorandum, SAMR-CQ, Assistant Secretary of the Army for Manpower and Reserve Affairs, 4 April 2011, subject: Delegation of Authority-Pay Plan for Army Civilian Physicians and Dentists Covered by the General Schedule (enclosed).
2. In accordance with reference 1 above, I hereby delegate to you the authority delegated to me by the Assistant Secretary of the Army for Manpower and Reserve Affairs to serve as Authorized Management Official (AMO) for covered civilian physicians and dentists in the Army to Commanders, Army Commands (ACOM), Army Service Component Commands (ASCC), Direct Reporting Units (DRU), and the Administrative Assistant to the Secretary of the Army (AASA). This authority may be further delegated, in writing, to a level not lower than a Commander (or equivalent) at or above the O6, GS-15, or equivalent level.
3. If the Commander of an ACOM, ASCC, DRU, or AASA, elects to retain AMO authority at his or her level, he or she may delegate this authority to his or her Deputy Commander at or above the O6, GS-15, or equivalent level. When the delegated and appointed AMO is absent, the individual designated to be "acting for" the AMO may exercise this authority.
4. This delegation is effective immediately and remains in effect until 30 September 2013, unless suspended, revoked, or superseded earlier.
