

SUBJECT: Extension of Delegated Examining Authority – South Central Civilian
Personnel Operations Center, Redstone Arsenal, AL, DD-AR-010

This responds to your memorandum of April 4, 2005, requesting a two-year extension of delegated examining authority for the South Central Civilian Personnel Operations Center (SCCPOC), Redstone Arsenal, Alabama. A review of the SCCPOC delegated examining operations conducted by this office in January 2005, revealed that the delegated examining unit is functioning in accordance with instructions provided by the Department of Defense, and that procedures contained in the U.S. Office of Personnel Management (OPM) Handbook are being followed. On this basis, the delegated examining authority for SCCPOC, Redstone Arsenal, Alabama, is extended until May 20, 2007, as shown in the attached delegation, unless terminated earlier. Your next Staff Assistance Visit (SAV) is tentatively scheduled for January 2007.

This delegation does not include Administrative Law Judge positions or positions covered by the Administrative Careers with America (ACWA) examination. OPM will continue to support competitive examining requirements for these positions. A list of positions covered by ACWA is attached.






